WHEREAS, Sections 8330, et seq. of the California Streets and Highways Code provide a procedure for the summary vacation of an excess right-of-way of a street or highway not required for street or highway purposes; and

WHEREAS, the portion of street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That a portion of Wilbur Avenue adjacent to Lots 1-3, Block 75 of Pacific Beach Subdivision Map 932, as more particularly shown on Drawing No. 15753-B on file in the office of the City Clerk as Document No. RR 257918, which is by this reference incorporated herein and made a part hereof, be and the same is hereby vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

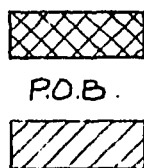
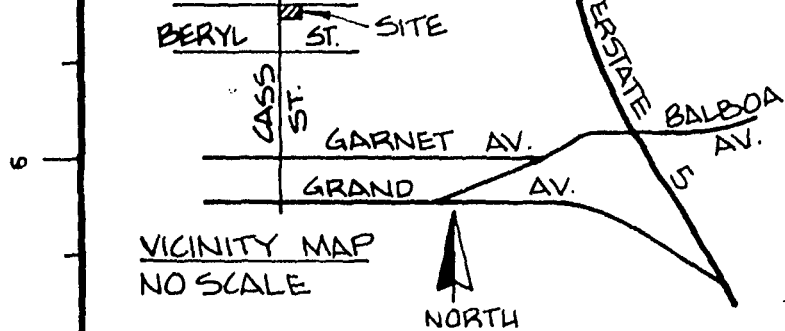
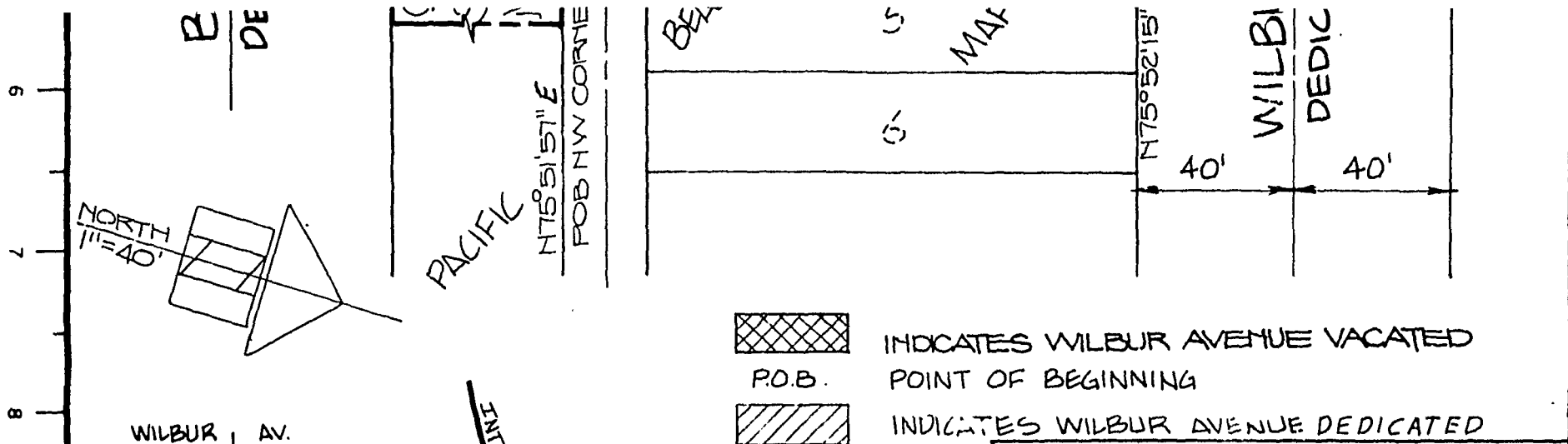

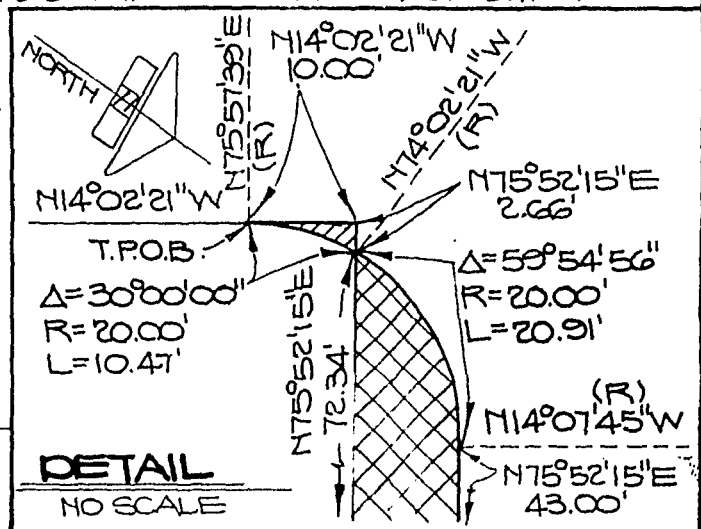


INDICATES WILBUR AVENUE VACATED
