APPROVING MAP OF CAMELOT TRAILS

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by William Gregory Clarke, a Licensed Surveyor, entitled "CAMELOT TRAILS, being a subdivision of Lots 15 through 28, in Block 117, and Lots 25 through 28, in Block 118, of Morena, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 809, filed in the office of the County Recorder of San Diego County, January 2, 1896, together with a portion of Huxley Street and the alley in Block 118, as dedicated to public use, and together with Ingulf Street, and portions of Illion Street, Huxley Street and the alley in Block 117, as closed and vacated for public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: Ingulf Street and portions of Illion Street and Ingulf Place, and said street and portions of streets are hereby declared to be public streets and dedicated to public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the

easements with the right of ingress and egress for the construction and maintenance of water facilities, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements for general utility purposes over, under, upon and across portions of Lot 18 as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements for open space over, under, upon and across Lots 18 and 19 as granted and shown on said map and subject to the conditions set forth thereon.


The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street and portions of public streets, together with the easements with the right of ingress and egress for the construction and maintenance of water facilities, as well as the easements for general utility purposes and the open space easements, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to record the street vacation approved by Council Resolution R-256674 on June 29, 1982, concurrently with the filing of this map.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
