RR- 257945 - 1 and RR- 257945 - 2, granting to said City easements for a public alley and drainage purposes in portions of Lots 1, 23 and 24 of Block 118 of Morena, Map No. 809, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for a public alley is hereby dedicated as and for a public alley.
