BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an agreement with IMPERIAL MUNICIPAL SERVICES GROUP, INC. for services to be provided as Lessor for a sum not to exceed \$10,000, payment of which shall be made solely from the proceeds of the issuance of the Certificates of Participation, for construction of the Western Division Police Station, a form of said Agreement being on file in the office of the City Clerk as Document No. RR-257958-1.


BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an agreement with JEFFRIES BANK NOTE COMPANY, for the printing of the Certificates of Participation for a sum not to exceed \$33,576, payment of which shall be made solely from the proceeds of the Certificate issue, a form of said agreement being on file in the office of the City Clerk as Document No. RR-257958-2.

BE IT FURTHER RESOLVED, that the City Property Department is hereby authorized to obtain a title insurance policy as required in the Trust Indenture with respect to the issuance of the Western Division Police Station Certificates of

Participation and the expenditure of a sum not to exceed \$13,000 is further authorized, payment of which shall be made solely from the proceeds of the Certificate issue.
