BE IT RESOLVED, by the Council of The City of San Diego as follows:


1. That the offer of JOY MANUFACTURING COMPANY is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of ONE (1) NO_x SELECTIVE CATALYTIC REDUCTION SYSTEM as follows:

Item 1.2.1 - Base Bid for a cost of \$408,475.00,
Additive Option Item 1.2.3 - Inlet and Outlet Transitions at a cost of \$7,150.00,
Additive Option Item 1.2.10 - Erection Supervision at a cost of \$15,785.00,
Additive Option Items 1.2.11 and 1.2.12 - Start-up Supervision (three (3) training days) and Supervision of Testing (two (2) testing days) at a cost of \$4,470.00,

for a total purchase price of \$435,880.00; terms net, sales tax is included in equipment price, plus an estimated freight charge of \$2,000.00.

2. That the City Auditor and Comptroller is hereby authorized to transfer \$459,774.00 within Sewer Revenue Fund 41506 from C.I.P. No. 43-118 Ocean Beach Trunk Sewer (70592) to C.I.P. No. 46-0700, Sewer Grant 530 (70292).
