BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. FOREMOST THREADED PROD., 2. BUDCO BOLT, 3. PELL MELL SUPPLY INC., and 4. CROWN BOLT INC. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of HARDWARE AND FASTENERS as may be required for a period of one (1) year beginning January 1, 1983 through December 31, 1983, per prices on file in the Purchasing Department, as follows:

1. FOREMOST THREADED PROD. for Section I - Carriage Bolts; Section II - Nails; Section III - Machine Screws; Section IV - Toggle Bolts and Lag Screws; terms 1% 10 days, with an option to renew contract for an additional one (1) year period, subject to a price escalation not to exceed 10% of prices at the end of the initial contract year.
2. BUDCO BOLT for Section V - Stainless Steel Cap Screws and Nuts; terms net 30 days, with an option to renew contract for an additional one (1) year period, subject to a price escalation not to exceed 10% of prices at the end of the initial contract year.
3. PELL MELL SUPPLY INC. for Section VI - Other Fasteners (Will Call); terms 1% 10 days.
4. CROWN BOLT INC. for Section VI - Other Fasteners (Will Call); terms 10% 20 days.
