

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$14,764.00 by ORTIZ ASSOCIATES, a partnership, for the CONSTRUCTION OF COLLIER PARK CHILDREN'S PLAY AREA, HOLLYWOOD PARK CHILDREN'S PLAY AREA AND KENSINGTON PARK CHILDREN'S PLAY AREA in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document Nos. 118251, 118252, and 118253.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$400.00 from PSD Fund 11560 to CIP No. 29-458, COLLIER PARK CHILDREN'S PLAY AREA; and to transfer \$1,200.00 from PSD Fund 15582 to CIP No. 29-459, HOLLYWOOD PARK CHILDREN'S PLAY AREA.
3. That the expenditure not to exceed \$400.00 from CIP No. 29-458, COLLIER PARK CHILDREN'S PLAY AREA and \$1,200.00 from CIP No. 29-459, HOLLYWOOD PARK CHILDREN'S PLAY AREA, is hereby authorized to supplement funds previously authorized by Resolution No. 257636, adopted December 13, 1982.
