filed in the office of the City Clerk of the City of San Diego, California, on FEB 22 1983, and bearing official Document No. W.O. 117983, be, and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for

CRANE INSTALLATION BUILDING 31.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to add CIP No. 37-410, CRANE INSTALLATION BUILDING 31 to the FY 1983 Capital Improvements Program.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$68,000.00 from Equipment Division Fund - Fire Loss 10502 to CIP No. 37-410, CRANE INSTALLATION BUILDING 31.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$68,000.00 from CIP No. 37-410, CRANE INSTALLATION BUILDING 31 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.


