
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized to amend the Master Agreement with CH2M HILL, INC., for engineering services in connection with the South Bay Wastewater System and related facilities from a cost not to exceed \$8,612,187 to a cost not to exceed \$8,643,419, for a total increase of \$31,232, under the terms and conditions set forth in that amendment to Master Agreement on file in the office of the City Clerk as Document No. RR- 257987.

BE IT FURTHER RESOLVED, that the expenditure of \$31,232 for the above purpose and related costs is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to proceed with Task Order No. 16 of the agreement with CH2M HILL, et al, a joint venture, in connection with the Point Loma Accelerated Projects for the sum of \$31,232.
