CORPORATION, a California corporation, all the City's right, title and interest in the slope easement, as more particularly described in said quitclaim deed.


That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.






PROPOSED MURPHY CANYON BUSINESS PA


