APPROVING MAP OF WATERIDGE I

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Phillip S. Butcher, a Licensed Surveyor, entitled "WATERIDGE I, being a subdivision of Lots 1 through 16 of Sorrento Corporate Park, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 10260, filed in the office of the County Recorder of San Diego County November 13, 1981, together with Lusk Boulevard, Corporate Park Avenue, Corporate Park Court and Sorrento Corporate Drive, as closed and vacated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Lusk Boulevard, Wateridge Circle and Wateridge Vista Drive, and said streets are hereby declared to be public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby rejects on behalf of The City of San Diego, a municipal corporation, those portions of Lots 7 and 23 marked "Reserved for Future Street," as shown on this map, under the provisions of Section 66440 of

the Government Code.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements listed in paragraphs 1 and 2 of the Owner's Certificate, as shown on this map and subject to the conditions set forth thereon.


The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said streets are accepted on behalf of the public as heretofore stated; that those easements listed in paragraphs 1 and 2 of the Owner's Certificate, as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated, and that said Council has rejected portions of Lots 7 and 23, marked "Reserved for Future Street."

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to record the street vacation approved by Council Resolution No. R-257417 on November 1, 1982 concurrently with the filing of this map.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
