RESOLUTION NUMBER R- 258015

Adopted on FEB 28 1983

WHEREAS, on July 14, 1982, President Reagan issued an Executive Order which establishes policies and procedures for replacing the existing OMB Circular A-95; and

WHEREAS, the current A-95 circular will remain in effect until April 30, 1983, when OMB will prescribe new regulations for implementing the Executive Order; and

WHEREAS, the Order transfers the responsibility for establishing intergovernmental review procedures from the federal government to the states; and

WHEREAS, the City Manager and Planning Director have recommended that the Council support the establishment of a State/regional intergovernmental review process and continue support of the San Diego Association of Governments (SANDAG) as the designated review agency within the San Diego region; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendations of the City Manager and Planning Director, regarding establishment of a State/regional intergovernmental review process, to replace the A-95 process, with SANDAG as the designated review agency, as set forth in the

Manager's Report to the Rules Committee, Report No. 83-35, a copy of which is on file in the office of the City Clerk as Document No. RR-258015 be and the same are hereby adopted.
