BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be and he is hereby authorized and empowered to initiate, for and on behalf of said City, a resolution of intention for the improvement of LOGAN HEIGHTS ALLEYS AND SEWER MAIN REPLACEMENT CONTRACT NO. 1, under the provisions of the Housing and Urban Development Block Grant Program B-82-MC-06-0542, the San Diego Municipal Code, and the Improvement Act of 1911.

2. That the City Manager be and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the improvement of LOGAN HEIGHTS ALLEYS AND SEWER MAIN REPLACEMENT - CONTRACT NO. 1, in the City of San Diego, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district to be included in the assessment for the work and improvements hereinabove mentioned.
