LEGAL DESCRIPTION

All that portion of the Southwesterly 1/4 of Pueblo Lot 1152, in the City of San Diego, County of San Diego, State of California, according to Official Map thereof described as follows:

Beginning at the Southeasterly corner of Lot 13, Block 135 of Central Park according to Map No. 435 filed November 9, 1887, in the Office of the County Recorder of said County; thence North 89°37'35" East, along the Easterly prolongation of the Southerly lines of Lots 1 thru 13 of said Block, a distance of 53.06 feet to a point on the Northerly prolongation of the centerline of Bancroft Street, shown as an unnamed 60 foot street on Map of Block 9 of Central Homestead according to Map No. 290 filed in the Office of said County Recorder, July 14, 1886; thence South 0°25'46" East along said prolongation 11.73 feet to a point on the Southerly line of said Pueblo Lot 1152; thence North 89°38'20" West along said Southerly line of Pueblo Lot 1152 a distance of 53.39 feet to a point on the Southerly prolongation of the Easterly line of said Lot 13 of Block 135; thence North 1°15'45" East along said Southerly prolongation a distance of 11.05 feet to the point of beginning.
