RESOLUTION NUMBER R- 258032

Adopted on FEB 28 1983

WHEREAS, Sections 8330, et seq. of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where a portion for a street or highway lies within property under one ownership and does not continue through such ownership or end touching property of another; and

WHEREAS, the abutting property owner has requested the vacation of Amboy Avenue adjacent to Lots 334, 335, 339, 340, 352, 353, 361-384, 387, 401-403; Mt. Albertine Avenue adjacent to Lots 332-338, 341-352, 384-386; Thronwood Street adjacent to Lots 354-360; and the Alley adjacent to Lots 387-401 in Cambridge Colony Unit 1, Map 9260, all within the Genesee East Subdivision (TM 02-232) boundaries, to facilitiate development of their property; and

WHEREAS, those properties adjoining the streets to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. Amboy Avenue adjacent to Lots 334, 335, 339, 340, 352, 353, 361-384, 387, 401-403; Mt. Albertine Avenue adjacent to Lots 332-338, 341-352, 384-386; Thornwood Street adjacent to


Lots 354-360; and the Alley adjacent to Lots 387-401 in Cambridge Colony Unit 1, Map 9620, all within the Genesee East Subdivision (TM 02-232) boundaries, as more particularly shown on Drawing No. 20692-D, on file in the office of the City Clerk as Document No. RR- 258032 -1, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That this resolution shall not become effective unless and until the Genesee East Subdivision has been approved by Council action. In the event that the above condition cannot be met, this resolution shall become void and of no further effect.

3. That the City Engineer shall advise the City Clerk of the approval of the aforementioned subdivision map, and that the City Clerk shall then cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
