WHEREAS, The City of San Diego recognizes there is a deficiency of affordable housing for military families in the San Diego region; and

WHEREAS, The City of San Diego recognizes the social and economic value to this region as a result of national defense efforts, and particularly the efforts of the United States Navy, and the City strongly supports these ongoing activities; and

WHEREAS, The City of San Diego is committed to assist and support efforts by the United States Navy to adequately and affordably house military personnel and their families; and

WHEREAS, the City and Navy, under the auspices of the SANDAG Military Housing Task Force, have worked closely together for the past two years to resolve the Navy's housing crisis in San Diego; and

WHEREAS, the Task Force has expended hundreds of hours accumulating over 100 possible sites for the FY '84 Navy Family Housing; and

WHEREAS, eleven of those sites have now been submitted for the NEPA process; and

WHEREAS, through the efforts of the Task Force, new and innovative ways to purchase existing units was accomplished in 1982 for the first time in history; and

WHEREAS, the Department of Defense has recently eliminated the FY '84 military housing appropriations for the San Diego region; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that in light of the extensive efforts and progress made by the SANDAG Military Housing Task Force, the City Council of The City of San Diego hereby expresses its opposition to this budget cut, and strongly urges the Department of Defense to reinstate this funding for military family housing in San Diego.

BE IT FURTHER RESOLVED, that the City Manager and the City Planning Director are hereby authorized and directed to provide any assistance that may be requested by the SANDAG Military Housing Task Force and the Department of Defense in acquiring appropriate housing for military families.
