Peter O. Solomonsen	Police	\$2,575	Mr. Solomonsen is a Police Officer. One year ago he earned a partial award of \$1,000 for his suggestion to discontinue the installation of push bumpers on marked Police vehicles. One year's experience has shown a savings of \$10,253. This is the remainder of his award plus \$500 in recognition of an additional intangible benefit.
Vincent DeLeva	General Services	\$1,240	Mr. DeLeva is an Electrical Supervisor in the Communications and Electrical Division. One year ago he earned a partial award of a Certificate of Merit for his suggestion to eliminate the installation of circuit breakers and their enclosures in multiple circuit street light installations. One year's experience has shown a savings of \$4,128.59. This is the remainder of his award.
Jack A. Mead	Park & Recreation	\$1,025	Mr. Mead is a Pool Maintenance Supervisor in the Central Division. He suggested the installation of heavy duty pipe on the pool solar blanket reels. This is expected to save \$6,835 in the first year in energy and replacement costs. This is a partial award pending a final 12 month Review.
