Russell W. Brand	General Services	\$ 860	Mr. Brand is an Apprentice Welder in the Equipment Division. One year ago he earned a partial award of \$860 for his suggestion to reinforce ejector blades on Leach Packers to prevent extensive damage. One year's experience has shown a savings of \$5,726. This is the remainder of his award.
Kenneth A. Martinosky Steven A. Gates	General Services	\$ 725	Mr. Martinosky and Mr. Gates are Mechanics in the Equipment Division. One year ago they earned a partial award of \$725 for their suggestion that the pressure regulator valves on the Dempster refuse packers be remounted to reduce damage caused by vibration. One year's experience has shown a savings of \$4,837. This is the remainder of their award.
William C. Adams	Fire	\$ 595	Mr. Adams is an Engineer. He earned a partial award of \$25 for his suggestion to implement a tool control program in the Fire Department. Actual experience has shown a savings of \$2,074. This is the remainder of his award.
Vincent DeLeva	General Services	\$ 580	Mr. DeLeva was an Electrician at the time of this suggestion in the Communication and Electrical Division. He earned a partial award of \$110 for his suggestion to replace defective mercury vapor street light luminaries with high pressure sodium types. Actual experience has shown an energy savings of \$6,912. This is the remainder of his award.
