Sharla A. Jensen Donna J Evans	Police	\$ 485	Ms. Jensen and Ms. Evans are Senior Clerks. One year ago they earned a partial award of \$455 for their suggestion to eliminate processing the 'Dealers Record of Sale of Revolver or Pistol' form by the Records Division. One year's experience has shown a savings of \$3,135. This is the remainder of their award.
Rodney L. Vandiver	Police	\$ 250	Mr. Vandiver is a Police Officer. He suggested to transfer purged traffic collision reports to the City Attorney's Office. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Jim A. Toci	Engineering & Development	\$ 190	Mr. Toci is an Assistant Electrical Engineer. He suggested eliminating unnecessary lighting along Quivera Road and Quivera Way. This is expected to save \$1,274 in energy savings. This is a partial award pending a final 12 month review.
Jack A. Mead	Park & Recreation	\$ 105	Mr. Mead is a Pool Maintenance Supervisor in the Central Division. He suggested that wheels be installed at both ends of the solar blanket reels. This is expected to save \$265 in the first year in equipment replacement costs. In addition, the award was increased by \$25 in recognition of the safety improvement.
