WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Michael O. Ansel	General Services	\$ 90	Mr. Ansel is a Stock Clerk in the Equipment Division. He suggested the purchasing of Solenoids from a different vendor. This is expected to save \$294 in the first year in material costs.
Martin J. Desmond	Engineering & Development	\$ 80	Mr. Desmond is an Associate Traffic Engineer. One year ago he earned a partial award of \$230 for his suggestion to install an extra twenty feet of cable in traffic lights with opticom installations. Actual experience has shown a savings of \$1,033. This is the remainder of his award.
Jack A. Mead	Park & Recreation	\$ 65	Mr. Mead is a Pool Maintenance Supervisor in the Central Division. He suggested to install straps to reinforce the steps on the diving boards and guard stand. This is expected to save \$210 in the first year in replacement costs.
David T. Yeargain	Financial Management	\$ 50	Mr. Yeargain is a Social Program Specialist II in Regy. He suggested the development of assessment tools and training guidelines for the Regy program. Although savings were difficult to identify, this was considered to be a significant operational improvement.
