Elvin W. Allen	General Services	\$ 50	Mr. Allen is an Operations Assistant in the Airports Division. He suggested that warning signs be installed outside the main entrance at Montgomery Field. Although savings were difficult to estimate this was considered to be a significant safety improvement.
Paul H. Mack	General Services	\$ 50	Mr. Mack is an Electrician in the Buildings Division. He suggested that a sealer be applied to the concrete floors of the water pump plants. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Arthur Belenzon	Park & Recreation	\$ 50	Mr. Belenzon is a District Manager in the Eastern Division. He suggested that a protective screen be installed on the high diving boards. Although savings were difficult to calculate, this was considered to be a significant public safety improvement.
Frank A. Hernandez	General Services	\$ 35	Mr. Hernandez is a Building Supervisor in the Buildings Division. He suggested a change in the maintenance of the Phil Swing and Bow Fountain. Although savings were difficult to calculate, this was considered to be a significant operational improvement.
