George E. Hubbard	Park & Recreation	\$ 30	Mr. Hubbard is an Equipment Operator II in the Coastal Division. He suggested that a secondary floor be installed in the case loaders. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
Robert T. Sawyer	Fire	\$ 25	Mr. Sawyer is a Firefighter. He suggested that smoke detectors be installed at fire stations. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
Jan E. Johnson	City Clerk	\$ 20	Ms. Johnson is a Senior Typist. She suggested reducing the size of the maps printed on the reverse side of the Notices of Public Hearing. Although savings were difficult to identify this was considered to be a significant operational improvement.
