RESOLUTION NUMBER R- 258049

Adopted on March 1, 1983

WHEREAS, at the time and place fixed for the opening of bids for the \$3,690,000 City of San Diego Certificates of Participation (Western Division Police Station Project) Evidencing a Proportionate Interest of the Holder Thereof in Lease Payments to be Made by the City of San Diego (the "Certificates"), all bids were publicly opened, examined and read, and a tabulation thereof has been entered in the minutes; and

WHEREAS, the bid of the bidder hereinafter named is the best bid made by a responsible bidder for the Certificates;

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. That the bid of M. L. Stern and Co., Inc. offering \$7,469,912.50, a premium of \$8.696056%, and accrued interest to date of delivery for the Certificates bearing interest payable semiannually at the rates of:




Section 3. That the interest rates on the Certificates are hereby fixed at the rates stated in Section 1 hereof.

Section 4. That the City Treasurer is directed to instruct the Trustee designated in the Trust Agreement (Western Division Police Station Project), Dated as of March 1, 1983 by and among Security Pacific National Bank, as Trustee, Imperial Municipal Services Group, Inc. and the City of San Diego, California, to deliver the Certificates to the successful bidder upon payment therefor to the Trustee and accrued interest, if any, to date of delivery.


