

RESOLUTION NUMBER R- 258054

Adopted on MAR 7 1983

WHEREAS, E. F. HUTTON LIFE INSURANCE COMPANY, a California corporation, has requested an exchange of drainage, water and sewer easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easements to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the acceptance by the City Manager of those deeds of E. F. HUTTON LIFE INSURANCE COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of May 26, 1982, conveying to said City drainage, water and sewer easements in Lot 14 of Torrey Pines Science Park Unit 3, Map No. 9230, as more particularly described in said deeds, copies of which are on file in the office of the City Clerk as Documents No. RR- 258054-1 and No. RR- 258054-2, is hereby approved.


2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 258054-3, quitclaiming to E. F. HUTTON LIFE

INSURANCE COMPANY, a California corporation, all of the City's right, title and interest in the drain easement in Parcel 1 of Parcel Map 10901, as more particularly described in said deed.

3. That the City Clerk is hereby authorized and directed to deliver the deeds, and a certified copy of this resolution to the Engineering and Development Department for further handling.
