
RESOLUTION NUMBER R- 258059

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendation of the Public Facilities and Recreation Committee to waive City fees for Park and Recreation Department recreation programs, except for contractual programs such as those conducted by recreation councils, for a one-year trial period, for individuals from families whose gross income in the past twelve (12) months falls within the Lower Living Standard Income Level is approved.
