WHEREAS, the Council of The City of San Diego, on July 6, 1982, in order to comply with the Local Coastal Program requirements under the California Coastal Act of 1972, adopted the LA JOLLA AND LA JOLLA SHORES LOCAL COASTAL PROGRAM ADDENDUM; and

WHEREAS, on September 22, 1982, said ADDENDUM was conditionally certified by the California Coastal Commission; and

WHEREAS, the Coastal Commission's conditions have been reviewed by the Planning Department of The City of San Diego and the La Jolla Shores Community Planning Groups; and

WHEREAS, the proposed amendments are designed to comply with the conditions of the California Coastal Commission, except for those conditions relating to the Parking and Transportation sections of the ADDENDUM; and

WHEREAS, the proposed amendments address issues in the Coastal Areas, Visual Resources and Special Communities segments of the ADDENDUM; and

WHEREAS, the Planning Commission, on January 27, 1983, held a public hearing, consistent with City Council Policy No. 880-7, to consider an amendment to the General Plan in order to retain consistency between said ADDENDUM amendments and the General Plan map and recommended adoption by the City Council of the amendments to the ADDENDUM and the Parking and Transportation sections of the ADDENDUM; and

WHEREAS, the City Council, on March 8, 1983, held a public hearing, consistent with City Council Policy No. 880-7, to consider an amendment to the General Plan and the amendments to the LA JOLLA AND LA JOLLA SHORES LOCAL COASTAL PROGRAM ADDENDUM; and

WHEREAS, the City Council has reviewed the proposed ADDENDUM amendments, hearing all public testimony; NOW,

IT IS RESOLVED, by the Council of The City of San Diego that they approve and adopt the LA JOLLA AND LA JOLLA SHORES LOCAL COASTAL PROGRAM ADDENDUM amendments to the "Progress Guide and General Plan" for the City of San Diego, which will be implemented after full and open certification by the California Coastal Commission, and authorize the transmittal of the LA JOLLA AND LA JOLLA SHORES LOCAL COASTAL PROGRAM ADDENDUM to the California Coastal Commission for final certification.
