

RESOLUTION NUMBER R- 258071

Adopted on MAR 3 1983

WHEREAS, the Council of The City of San Diego, on July 6, 1982, in order to comply with the Local Coastal Program requirements under the California Coastal Act of 1976, adopted the LA JOLLA AND LA JOLLA SHORES LOCAL COASTAL PROGRAM ADDENDUM; and

WHEREAS, on September 22, 1982, said ADDENDUM was conditionally certified by the California Coastal Commission; and

WHEREAS, the Coastal Commission's conditions have been reviewed by the Planning Department of The City of San Diego and the La Jolla Shores Community Planning Groups; and

WHEREAS, the proposed amendments are designed to comply with the conditions of the California Coastal Commission, excepting those conditions relating to the Parking and Transportation sections of the ADDENDUM; and

WHEREAS, the proposed amendments address issues in the Hazard Areas, Visual Resources and Special Communities components of the ADDENDUM; and

WHEREAS, the Planning Commission, on January 27, 1983, held a concurrent public hearing consistent with City Council Policy No. 600-7, to consider an amendment to the General Plan in order to retain consistency between said ADDENDUM amendments and the General Plan map and recommended adoption by the City Council of

the amendments to the ADDENDUM and the General Plan and reaffirmed the existing recommendations in the Parking and Transportation sections of the ADDENDUM; and


WHEREAS, the City Council, on March 8, 1983, held a concurrent public hearing, consistent with City Council Policy No. 600-7, to consider an amendment to the General Plan and the amendments to the LA JOLLA AND LA JOLLA SHORES LOCAL COASTAL PROGRAM ADDENDUM; and

WHEREAS, the City Council has reviewed the proposed ADDENDUM amendments, hearing all public testimony; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that it hereby approves and adopts the LA JOLLA AND LA JOLLA SHORES LOCAL COASTAL PROGRAM ADDENDUM amendments and amendments to the "Progress Guide and General Plan" for The City of San Diego, which will be implemented after full and effective certification by the California Coastal Commission and directs and authorizes the transmittal of the LA JOLLA AND LA JOLLA SHORES LOCAL COASTAL PROGRAM ADDENDUM, as amended, to the California Coastal Commission for final certification.
