WHEREAS, the Planning Commission of The City of San Diego has reviewed the proposed SORRENTO HILLS COMMUNITY PLAN prepared by a private consultant in conjunction with City staff, which Plan was developed with commercial and industrial uses creating substantial job opportunities and adequate public facilities to be provided as needed; and

WHEREAS, the Plan requires adoption of a financing plan by the City Council prior to recordation of the first final map to insure funding for all public facilities; and

WHEREAS, the Planning Commission held a public hearing on February 17, 1983 to consider said Plan and voted 4 to 1 to approve and recommend adoption of the proposed SORRENTO HILLS COMMUNITY PLAN, a copy of which is on file in the office of the Planning Department of The City of San Diego; and

WHEREAS, the Council of The City of San Diego has reviewed and considered the proposed SORRENTO HILLS COMMUNITY PLAN; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the SORRENTO HILLS COMMUNITY PLAN be, and the same is hereby approved and adopted.

WHEREAS, the Planning Commission of The City of San Diego held a public hearing on February 17, 1983 to consider an amendment to the Land Use Map of the Progress Guide and General Plan for the City of San Diego for the purpose of shifting those properties known as the SORRENTO HILLS COMMUNITY PLAN from the Future Urbanizing to Planned Urbanizing; and

WHEREAS, the proposal conforms to the guidelines and requirements of the Progress Guide and General Plan of The City of San Diego for shifting a site from Future Urbanizing to the Planned Urbanizing area; and

WHEREAS, the proposal conforms to City Council Policy No. 10000 which specifies the guidelines and requirements for shifting a site from the Future Urbanizing to the Planned Urbanizing area (an evaluation of the nine factors relative to an "In-Use" site are contained on page 3-175 of SDR No. 8073-001); and

WHEREAS, the Planning Commission has voted 8 to 2 to approve the amendment proposed by the City Council of an amendment to the Land Use Map of the Progress Guide and General Plan for the City of San Diego shifting those properties known as SORRENTO HILLS COMMUNITY PLAN from Future Urbanizing to the Planned Urbanizing area; and

WHEREAS, the Council of The City of San Diego has unanimously passed to shift the SORRENTO HILLS COMMUNITY PLAN from Future Urbanizing to the Planned Urbanizing area;

IT IS HEREBY ORDERED by the Council of the City of San Diego that the Land Use Map of the Progress Guide and General Plan for the City of San Diego be and the same is hereby amended to shift those properties known as SORRENTO HILLS COMMUNITY PLAN from Future Urbanizing to the Planned Urbanizing area.
