

RESOLUTION NUMBER R- 258075

Adopted on MAR 3 1983

WHEREAS, the Planning Commission of The City of San Diego held a public hearing on February 17, 1983 to consider an amendment to the Land Use Map of the Progress Guide and General Plan for The City of San Diego for the purpose of shifting those properties known as the SORRENTO HILLS COMMUNITY PLAN from Future Urbanizing to Planned Urbanizing; and

WHEREAS, the proposal conforms to the guidelines and requirements of the Progress Guide and General Plan of The City of San Diego for effecting a shift from Future Urbanizing to the Planned Urbanizing area; and

WHEREAS, the proposal conforms to City Council Policy No. 600-30 which specifies the guidelines and requirements for effecting a shift of land from the Future Urbanizing to the Planned Urbanizing area (an evaluation of the nine factors relative to an "incremental" shift are outlined on page 3-176 of EIR No. 81-12-33); and


WHEREAS, the Planning Commission has voted 5 to 0 to approve and recommend adoption by the City Council of an amendment to the Land Use Map of the Progress Guide and General Plan for The City of San Diego, shifting those properties known as SORRENTO HILLS COMMUNITY PLAN from Future Urbanizing to the Planned Urbanizing area, and

WHEREAS, the Council of The City of San Diego has

considered the proposal to shift the SORRENTO HILLS COMMUNITY  
PLAN from Future Urbanizing to the Planned Urbanizing area; NOW,  
THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego  
that the Land Use Map of the Progress Guide and General Plan for  
The City of San Diego be and the same is hereby amended to shift  
those properties known as SORRENTO HILLS COMMUNITY PLAN from  
Future Urbanizing to the Planned Urbanizing area.
