

RESOLUTION NUMBER R- **258082**

Adopted on MAR 14 1983

WHEREAS, on January 14, 1971, The City of San Diego entered into a Subdivision Improvement Agreement with CONNECTICUT MUTUAL LIFE INSURANCE COMPANY, a corporation, and MACCO COMMERCIAL/INDUSTRIAL, INC., a California corporation, subdividers of STADIUM VIEW, filed in the office of the City Clerk on January 28, 1971 as Document No. 734609, which agreement was thereafter amended by Council Resolution No. 211885, which substituted CONNECTICUT MUTUAL LIFE INSURANCE COMPANY, a corporation, as subdivider, and granted an extension of time to the subdivider to August 31, 1979 to complete the work under said agreement; and

WHEREAS, 20% of the work required under said agreement, consisting of sidewalk, fire hydrant, two street lights and removal of a wall and fence from the public right-of-way, remains to be completed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that CONNECTICUT MUTUAL LIFE INSURANCE COMPANY, a corporation, subdivider of STADIUM VIEW, is hereby declared to be in default under Subdivision Improvement Agreement filed in the office of the City Clerk on January 28, 1971 as Document No. 734609.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized and directed to complete the improvements required in accordance with the terms of the subdivision agreement, Document No. 734609.
