BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$253,500.00 from Capital Outlay Fund 30245, CIP No. 35-053, SAN YSIDRO BRANCH LIBRARY EXPANSION of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
