
BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a five (5) year lease agreement with PACIFIC SOUTHWEST REALTY COMPANY, a Delaware corporation, for 2,220 rentable square feet of space on the 9th floor of the Security Pacific Plaza Building, at a rental of \$3,263.40 per month, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No. RR- 258111 .

BE IT FURTHER RESOLVED, that the appropriation of a sum not to exceed \$39,160.80 for the purpose of paying the first year's rent is hereby authorized and approved.
