BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Lease Agreement with DAVID W. WEIR and LOLA L. WEIR, dba BALBOA PARK RAILROAD, for operation of the miniature railroad located on City-owned property within Balboa Park, for a term of ten (10) years, at a minimum annual rental of \$18,000 or twenty-five percent (25%) of gross income from operation of the miniature train and ten percent (10%) of gross income from sale of merchandise, whichever is greater, on an annual basis, under the terms and conditions set forth in that Lease Agreement on file in the office of the City Clerk as Document No.
