A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO APPROVING PHASE II OF THE LOCAL ARTS PLAN, AS SUBMITTED BY COMBO TO THE CALIFORNIA ARTS COUNCIL AND AUTHORIZING EXECUTION OF A GRANT CONTRACT WITH THE CALIFORNIA ARTS COUNCIL.

WHEREAS, the California Arts Council (CAC) and the California State Legislature have established a State/Local Partnership Program designed to:

1. Encourage local cultural planning and decision making;
2. Broaden the base and enhance the responsiveness of Arts Council programming by reaching previously underserved constituencies; and
3. Heighten opportunities for artists and interested citizens to directly affect arts policies and practices; and

WHEREAS, the City Council, by Resolution No. R-257537, adopted on November 23, 1982, approved participation in the 1982-83 State/Local Partnership Program; and

WHEREAS, the City Council in that resolution designated the Combined Arts and Education Council of San Diego (COMBO) as The City of San Diego's contractor with CAC for purposes of that program; and

WHEREAS, COMBO was responsible for developing and submitting Phase II of the local arts plan; and


WHEREAS, that phase has now been submitted to the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council does hereby approve Phase II of the local arts plan as submitted by COMBO.

BE IT FURTHER RESOLVED, that COMBO is hereby authorized to execute the 1982-83 Local Priorities Grant Contract with the California Arts Council, contingent upon approval of the phase by the CAC.
