

RESOLUTION NO. R-258132Adopted on MAR 22 1983

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Jeston C. Fedeli	Treasurer	\$5,000	Ms. Fedeli is an Administrative Aide II in the Treasurer's Office. She suggested that the City contract with an outside agency to collect for out-of-state parking citations. This is expected to result in an increase in revenue of \$62,933 in the first year.
Leroy Murphy	Engineering & Development	\$3,030	Mr. Murphy is a Senior Engineering Aide in the Engineering and Development Department. He suggested eliminating the painting of the word O-N-L-Y in turn lanes. \$10,000 was actually saved in the first year in costs for labor and material.
Maureen Whelan	General Services	\$2,500	Ms. Whelan is a Senior Clerk in the Buildings Division. She suggested establishing a separate store for postage and computerizing metered mail accounting. This is expected to save \$28,148 in the first year in costs for time and material. This is a partial award pending a final 12 month review.
Paul Zielins	General Services	\$ 980	Mr. Zielins is a mechanic in the Equipment Division. He suggested installing a Variable Speed Governor on the Detroit Diesel trash trucks. This is expected to save \$6,513 in the first year in costs for time and material. This is a partial award pending a final 12 month review.
