WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
James A. McQuary	General Services	\$ 395	Mr. McQuary is a sign painter in the Streets Division. He suggested that the material used for street name signs be replaced with .080 sheet aluminum. This is expected to save \$1,314 in the first year in cost for material.
Richard Mr. Dell Orfano	Engineering & Development	\$ 255	Mr. Dell Orfano is an Assistant Electrical Engineer. One year ago he earned a partial award of \$190 for his suggestion to route two copies of "as built" drawings to the street light energization section. One year's experience has shown a savings of \$1,487. This is the remainder of his award.
Douglas S. Johnson	General Services	\$ 185	Mr. Johnson is a Machinist in the Equipment Division. He suggested that a new throttle assembly be installed on the 1978 Crane Carriers trash trucks. This expected to save \$614 in the first year in costs for time and material.
Tom W. Holt	Engineering & Development	\$ 140	Mr. Holt is a Senior Survey Aide in Engineering and Development. He suggested revising the method for preparing corner records. This is expected to save \$929 in the first year in costs for time. This is a partial award pending a final 12 month review.
