One year ago she earned a partial award of \$90 for her suggestion to change the equipment folders filing system from horizontal to vertical. One year's experience has shown a savings of \$640. This is the remainder of her award.
Veronica McCune	General Services	\$ 25	Ms. McCune is an Intermediate Clerk in the Buildings Division. She suggested that notification be sent to departments to separate mail according to zip codes. Although savings were difficult to identify, this was considered to be a significant operational improvement.
