BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for

CONSTRUCTION OF CHANNELIZATION IMPROVEMENTS AT VARIOUS LOCATIONS FISCAL YEAR 1983.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer within Capital Outlay Fund 30245, \$40,000.00 from CIP No. 61-001, SIGNAL INSTALLATIONS TO ACCOMMODATE SUDDEN CHANGES IN TRAFFIC PATTERNS/VOLUMES; \$44,000.00 from CIP No. 58-004, MISCELLANEOUS IMPROVEMENTS ON CITY STREETS; and \$30,000.00 from CIP No. 62-156.1, GRAND AVENUE AND JEWELL STREET, to CIP No. 63-003, CHANNELIZATION IMPROVEMENTS.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$139,000.00 from Capital Outlay Fund 30245, CIP No. 63-003, CHANNELIZATION IMPROVEMENTS of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
