BE IT RESOLVED, by the Council of The City of San Diego, that its intention is hereby expressed to conduct a hearing which will be held in the City Council Chambers on the 12th Floor of the City Administration Building, 202 "C" Street, San Diego, California, on May 10, 1983, at 9:00 a.m., at which time the City Council will consider whether or not to annex the "Hillsborough East Reorganization" as more particularly

described in Exhibit "A" attached hereto, to the Open Space Park Facilities District No. 1.

BE IT FURTHER RESOLVED, that the owners of said property or any portion thereof may appear at the hearing and be heard, orally or by writing, signed by them, and may present evidence in support of or in opposition to the proposed annexation.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to post a copy of this resolution on the bulletin board of the City Administration Building and to cause a copy of this resolution to be published in the Daily Transcript once a week for two weeks prior to the hearing, the posting and first publication to be on or before the tenth day prior to the day of the hearing.
