RESOLUTION NUMBER R- 258153

Adopted on MAR 28 1983

WHEREAS, on February 7, 1983, the City Council approved the 1983-84 Legislative Policy Guidelines; and

WHEREAS, those guidelines have been incorporated in Council Policy 000-19; and

WHEREAS, subsequent to the February 7, 1983 action, it was recommended that Council Policy 000-19 be amended to direct the Department of Intergovernmental Relations to support legislation that would establish state and federal tax credits and incentives to encourage homeowners, businesses and industries within areas impacted by aircraft noise to install materials to deflect or absorb detrimental levels of noise; and

WHEREAS, the Rules Committee reviewed said recommended amendment on March 7, 1983 and recommends approval by the full Council; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that Council Policy 000-19, dated February 7, 1983, be and the same is hereby amended by amending Section III, Environmental Protection Policy, subsection A. to add thereto a new subsection A.5. to read as follows:

Efforts to establish state and federal tax credits and tax incentives to encourage homeowners, businesses and industries, within areas impacted by aircraft noise in excess of the state airport noise criteria as measured by

the current Community Noise Equivalent Level (CNEL), to
install materials designed to deflect, absorb or insulate
against detrimental levels of aircraft noise.
