



BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller is hereby authorized to increase CIP 52-140, Otay Mesa Road, by \$4,224,417, said amount to be reimbursed to the Capital Outlay Fund by the County of San Diego in the amount of \$2,257,000, State of California in the amount of \$2,130,000 and GSA in the amount of \$61,535 and by reducing Federal Aid Urban reimbursement in the amount of \$224,118, in accordance with resolutions previously approved by Council.
