A RESOLUTION DECLARING THE RESULTS OF THE SPECIAL MUNICIPAL ELECTION HELD IN THE CITY OF SAN DIEGO ON TUESDAY, MARCH 15, 1983.

WHEREAS, a special municipal election was held in the City of San Diego on Tuesday, March 15, 1983, pursuant to the provisions of Ordinance No. 15882 (New Series) adopted January 3, 1983, for the purpose of electing a Mayor to fill the unexpired term of Pete Wilson; and

WHEREAS, a copy of the certificate of the Registrar of Voters of San Diego County canvassing the returns of the special municipal election, as certified to the City Clerk, has been duly received; and

WHEREAS, a canvass of the election has been completed and the City Clerk has certified the results to the City Council;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council finds and determines pursuant to the provisions of Section 27.2206 of the San Diego Municipal Code, as follows:

I

The whole number of votes cast in the City was 187,484.


The number of votes in each precinct cast for each person are recorded in the Election Returns Book, which book is a part of the records of this Council.
