APPROVING MAP OF HIDDEN CANYON TOWNHOUSES

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by William Gregory Clarke, a Licensed Surveyor, entitled "HIDDEN CANYON TOWNHOUSES, being a subdivision of portions of Lots 95 and 96 of Brierwood Unit No. 5 in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 4846, filed in the office of the County Recorder of San Diego County on September 22, 1961, and a portion of Lot 2 of Lorraine Heights Unit No. 1, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 5088, filed in the office of the County Recorder of San Diego County on November 30, 1962," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public Marlesta Drive, and said street is hereby declared to be a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication that portion of Lot 23 marked "Reserved for Future Street," as shown on this map, under the provisions of Section

66440 of the Government Code.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of water and drainage facilities and slope rights, as granted and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements for open space under, upon and across Lots 22, 23 and 24, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated; that said Council has rejected a portion of Lot 23, marked "Reserved for Future Street;" that the easements with the right of ingress and egress for the construction and maintenance of water and drainage facilities, as well as the easement for slope rights and the open space easements, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
