BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Donald R. Rogers, a Licensed Surveyor, entitled "ULTIMA, being a subdivision of a portion of Lot 45 of Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California, according to partition Map thereof made in an action entitled 'Commercial Bank of San Diego vs. Juan M. Luco, et al.,' on file in the office of the County Clerk of said San Diego County," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for open space over, under and upon that portion of Lot 1, as granted and shown on said map and subject to the conditions set forth thereon.


