WHEREAS, in December 1982, the City Attorney's office submitted a proposal for inclusion in the City's 1983 Legislative Program to amend certain provisions of the Public Safety Officers Procedural Bill of Rights concerning appeals, disclosure of records, and inspection of work areas; and

WHEREAS, on December 6, 1982, the Rules Committee voted to continue the matter to March 1983 to determine if sufficient legislative support from other public agencies existed; and

WHEREAS, most of the public agencies polled were nonsupportive of the measure; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City of San Diego does not desire to sponsor amendments to the Public Safety Officers Procedural Bill of Rights.
