BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to authority conferred by and in accordance with the provisions of Section 82.19 of the San Diego Municipal Code, the following street in the City of San Diego be and it is hereby declared to be a ONE WAY STREET:


FIFTH AVENUE between Broadway and Market Street northbound.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same are hereby authorized to be made on said street, and that the regulations hereinabove imposed shall become effective upon the installation of such signs.

BE IT FURTHER RESOLVED, that Resolution No. R-256233 which established FIFTH AVENUE between Broadway and Market Street as a two way street is hereby rescinded.

BE IT FURTHER RESOLVED, that City Council Policy 600-32 entitled "Preferred Street System for Centre City" be and is hereby amended to indicate that FIFTH AVENUE between Broadway and Market Street be a ONE WAY northbound street.
