BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that grant deed of THE FIELDSTONE COMPANY, executed in favor of The City of San Diego, bearing date of February 22, 1983, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 258269, granting to said City for public park purposes, a portion of the Southeast Quarter of the Northwest Quarter of Section 35, Township 14 South, Range 3 West, San Bernardino Meridian, as more particularly described in said deed, be, and the same is hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$180,000 from Park Service Fees, CIP 29-423, for acquisition of the above park land is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the addition of CIP 29-423, Winterwood Lane Park, to the FY 1983 Capital Improvements Program, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$40,597 from PSD Fund 11210; \$28,092 from PSD Fund 11211; \$79,423 from PSD Fund 13220, and \$31,888 from PSD Fund 13430.

BE IT FURTHER RESOLVED, that the City Clerk is hereby

authorized and directed to deliver the deed and a certified copy of this resolution, attested by him under seal, to the Property Department for further handling.
