
BE IT RESOLVED, by the Council of The City of San Diego as follows:

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$53,000 from Gas Tax Fund 30219, is hereby authorized, solely and exclusively for the purpose of providing funds for the above program.
