

WHEREAS, the Planning Commission of The City of San Diego held a public hearing on February 17, 1983, to consider the proposed OTAY MESA-NESTOR COMMUNITY PLAN AMENDMENT; and  
WHEREAS, the Planning Commission approved and recommended to the City Council adoption of the OTAY MESA-NESTOR COMMUNITY PLAN AMENDMENT; and  
WHEREAS, City Council Policy 800-7, requires that the public hearings to consider revisions of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO shall be scheduled concurrently with all public hearings on proposed community plan amendments; and  
WHEREAS, the Planning Commission of The City of San Diego held concurrent public hearings to consider the OTAY MESA-NESTOR COMMUNITY PLAN AMENDMENT, and amendment of the GENERAL PLAN in order to retain consistency between said amendments; and  
WHEREAS, on February 17, 1983, the Planning Commission approved and recommended for adoption by the City Council an amendment to the GENERAL PLAN; and  
WHEREAS, California Government Code, Section 65600, provides that amendments to the GENERAL PLAN may not be adopted until the first time after the date of the hearing; and  
WHEREAS, it is the intention of the City Council to consider amendments to the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO at hearings conducted on a semi-annual basis; and  
WHEREAS, it is the intention of the City Council to conduct a hearing on proposed amendments that will result in changes to the PROGRESS GUIDE AND GENERAL PLAN during the year; but such amendments shall not become effective until enacted at the semi-annual hearing conducted for the purpose of amending the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO; and  
WHEREAS, the Council of The City of San Diego held a public hearing to consider the OTAY MESA-NESTOR COMMUNITY PLAN AMENDMENT; and  
WHEREAS, the Council of The City of San Diego, by majority vote, approved the OTAY MESA-NESTOR COMMUNITY PLAN AMENDMENT; NOW, THEREFORE,
