

RESOLUTION NUMBER R- 258293

Adopted on APR 19 1983

WHEREAS, the Planning Commission of The City of San Diego held a public hearing on February 17, 1983, to consider the proposed OTAY MESA-NESTOR COMMUNITY PLAN AMENDMENT; and

WHEREAS, the Planning Commission approved and recommended to the City Council adoption of the OTAY MESA-NESTOR COMMUNITY PLAN AMENDMENT, and

WHEREAS, City Council Policy 600-7, requires that the public hearings to consider revisions of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO shall be scheduled concurrently with all public hearings on proposed community plans; and

WHEREAS, the Planning Commission of The City of San Diego has held concurrent public hearings to consider the OTAY MESA-NESTOR COMMUNITY PLAN AMENDMENT, and amendment of the GENERAL PLAN in order to retain consistency between said plans; and

WHEREAS, on February 17, 1983, the Planning Commission approved and recommended for adoption by the City Council an amended GENERAL PLAN; and

WHEREAS, California Government Code, Section 65869 provides that mandatory elements of the GENERAL PLAN may not be amended more than three times per year; and

WHEREAS, it is the intention of the City Council to consider amendments to the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO at hearings conducted on a semi-annual

basis; and

WHEREAS, it is the intention of the City Council to conduct a public hearing on proposed actions that will result in changes to the PROGRESS GUIDE AND GENERAL PLAN during the year, but such changes shall not become effective until enacted at the semi-annual hearing conducted for the purpose of amending the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO; and

WHEREAS, the Council of The City of San Diego held a public hearing to consider the OTAY MESA-NESTOR COMMUNITY PLAN AMENDMENT; and

WHEREAS, the Council of The City of San Diego, by majority vote, approved the OTAY MESA-NESTOR COMMUNITY PLAN AMENDMENT;  
NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That this Council hereby approves that plan entitled OTAY MESA-NESTOR COMMUNITY PLAN AMENDMENT, a copy of which is on file in the office of the City Clerk as Document No. RR-  
258293.

2. That the OTAY MESA-NESTOR COMMUNITY PLAN AMENDMENT shall become effective upon adoption of an appropriate amendment to the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO incorporating said plans, an omnibus hearing on this and other amendments having been scheduled in June 1983.
